**GUIDELINES FOR THE  
INSTANT MONEY GAME AGENCY**

1. Agent must sign agreement to purchase tickets.
2. Payment for tickets must be made by cash, certified cheque or bank manager's cheque.
3. Tickets are purchased at 10% discount.
4. Minimum purchase – any instant money game at value \$900.00.
5. Letter of authorization required if agent sends a representative to purchase tickets.
6. Tickets purchased should be checked before leaving the office of the Board.
7. Agents can purchase tickets as often as they like.
8. The Board must be notified of change in address.
9. Three (3) month period after close of game within which to sell and redeem tickets purchased from the Board.
10. Agents may encash tickets for participants up to the value of \$100.00 per ticket.
11. Agents are paid Sellers' Prizes of \$1,000.00 for selling jackpot prizes of \$10,000.00 and over.
12. Upon request, tickets may be distributed to agents daily by our Lottery Sales Representatives.
13. Agents must stamp back of tickets prior to redemption.
14. Two (2) months notice required for termination of agency.
